फरीदाबाद। होडल के एक कारोबारी को हन्नी ट्रैप में फंसा अपहरण कर नोएडा ले जाने और दुष्कर्म के झूठे मामले में फंसा कर एक करोड़ रुपये मांगने के आरोप में पुलिस ने एक महिला सहित दो लोगों को गिरफ्तार किया है। आरोपियों ने कारोबारी से 16 लाख रुपये लेकर छोड़ा था। पुलिस ने दोनों आरोपियों को होडल अदालत में पेश कर उन्हें रिमांड पर लिया है। पुलिस को इनके छह साथियों की तलाश है।
