

- 1. Pursuant to Section 108 of the Act and 3(1) of Rule 20 of the Companies (Management & Administration) Rules, 2014, the Notice convening the Meeting including Statement under section 102 of the Act has been dispatched on September 2, 2017 and by e-mail on September 6, 2017; and subsequently, the notice convening the meeting was also placed on the website of the Company. The members of the Company were given an option to vote electronically on e-voting platform, provided by the Central Depository Services (India) Limited (CDSL).
- The Public Advertisement with respect to dispatch of notices and conducting of voting through electronic means was published in an English newspaper having wide circulation and a vernacular newspaper on the September 3, 2017.
- The remote e-voting period remained open from Monday, 25th September, 2017 (9:00
 A.M.) and end on Wednesday, 27thSeptember, 2017 (5:00 P.M.) on the designated website www.svotingindia.com of Central Depository Services (India) Limited (CDSL).
- 4. The Company has appointed Central Depository Services (India) Limited (CDSL) as the service provider for providing the facility of remote e-voting to the members of the Company. The service provider has provided a system for recording the votes of the shareholders electronically on all the items of the businesses sought to be transacted at the 24*AGM of the Company.
- 5. The Members of the Company as on the "cut off date" i.e. 21st September, 2017 were entitled to avail the facility of remote e-voting or voting at the AGM on the proposed resolutions (Item nos. 1 to 3) as set out in the notice dated August 25, 2017.

- 6. In line with the provisions of the Companies Act, 2013 and in terms of the clarification issued by Ministry of Corporate Affairs, voting by show of hands was not permitted at the General Meeting where remote e-voting has been offered to the members. Therefore, the Chairman ordered for poll at AGM as per Rule 20 of Companies (Management and Administration) Amendment Rules, 2015 & Rule 21 of the Companies (Management and Administration) Rules, 2014.
- 7. The Management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013 and rules made thereunder and SEBI (Listing Obligation & Disclosure Requirements) Regulations, 2015 of 24th AGM of the Company. My responsibilities as acrutinizer are restricted to make a Scrutinizer's Report of the votes cast "For" or "Against" the resolutions stated in the notice of AGM.
- 8. After completion of Poll at the AGM votes casted by the members were reconciled with the records maintained by the Registrar and Transfer Agents of the Company and the Authorizations/Proxies lodged with the Company. A detailed register was maintained containing the particulars of the Members who participated in Poll at AGM.

A register has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, folio number or client id of the shareholders, number of shares held by them, nominal value of such shares. As there were no shares with differential voting rights, the question of maintaining the list of shares with differential voting rights did not arise.
